The 29th Annual General Meeting of the members of the Company was held on Friday, 02nd September, 2022 at 10.00 a.m. at "7C, 1st Floor, 'J' Block Shopping Centre, Saket New Delhi-110017.

Mrs. Monika Tyagi, Company Secretary of the Company welcomed the members of the Company and read the Auditors' Report dated 27th May, 2022.

Mr. Harnand Tyagi, Director of the Company chaired the Annual General Meeting.

11 members (including authorised representatives) attended the meeting as per the records of attendance. After ascertaining that the requisite quorum for the meeting was present, the Chairman called the meeting to order.

The Chairman addressed the members with particular reference to the financial performance of the Company for the financial year ended on 31st March, 2022.

Then the Company Secretary informed the members that pursuant to the provisions of Section 108 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 amended up to date and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015, the Company had provided the e-voting facility to the Members of the Company in respect of businesses to be transacted at the Annual General Meeting. The e-voting period commenced on 30th August, 2022 at 9.00 a.m. and ended on 01st September, 2022 at 5.00 p.m.

3. Re-Appointment of M/s B. K. Kapur & Company, Chartered Accountants as Statutory Auditors.
4. Re-Appointment of Mr. Harish Kumar Dhingra (DIN: 07716192) as Independent Director of the Company.
