

- The Company operate in a single reportable segment i.e loan and investments. The Company operates in single geographical segment i.e domestic
- Previous period figures stated above have been regrouped and/or reclassified wherever necessary to make them comparable with current period figures.
- The outbreak of Covid-19 pandemic across the globe has led to significant decline, volatility and slowdown in the economic activities. However, the impact assessment of COVID-19 is a continuing process given the uncertainties associated with its nature and duration. The actual impact of the pandemic on the Company may be different from that estimated as at the date of approval of these financial results. The Company will continue to closely monitor any material changes to future economic conditions.
